

Scholarships!

For entry in 2016-2017 we have two scholarships available for international students:

- Commonwealth Shared studentship for the LLM Gender, Conflict and Human Rights programme.
- Garfield Weston Trust bursary for either LLM Human Rights and Transitional Justice or LLM Gender, Conflict and Human Rights (a 2000 pound bursary).

Our LLM programmes are open to graduates from a range of disciplines: Entry requirements are a second class Honours degree or above or equivalent recognised qualification in Law, Social Sciences, Humanities or a cognate discipline.

Commonwealth Shared studentship

This is for the LLM Gender, Conflict and Human Rights programme.

This is for students from developing countries who would otherwise not be able to study in the UK.

Garfield Weston Trust bursary

This bursary is for either programme (a 2000 pound bursary).

Garfield Weston Trust bursary for either programme (a 2000 pound bursary). This is a scholarship to support one highly qualified international student from the *Middle East / North Africa (MENA)** region coming to Northern Ireland to participate in one of our two LLM programmes.

It has been graciously provided by the Garfield Weston Trust. This will be awarded on a partial fee basis, whereby a portion of the fees required of the successful applicant will be paid by the TJI (£2000).

In selecting the successful applicant, particular attention will be paid to the likely benefit to the wider community of the applicant's participation on the degree. Such likely benefit can be evidenced through the applicant's work to date to the benefit of the wider community, to include a discussion of how participation in the programme will add value to the applicant's ongoing work and future plans. In addition, the applicant's academic credentials, as well as the likely benefit to the individual applicant, will be considered.

The scholarship will be awarded on the basis of evaluation by the Transitional Justice Institute Directorate in consultation with the LLM Course Director.

The TJI reserves the right not to award any scholarship in a particular year should suitably qualified candidates not be identified in the applicant pool.
